**Sub: Release of Agriculture connection under Tatkal Scheme 2010 -  
Providing Option of Drip Irrigation for availing overriding priority**

With reference to above, you have asked some of the clarification is required to implement the scheme which reply in **bold letter** is as under:

- **As per clause No. 2**

*"Those, who intends to adopt for drip irrigation will have to register with M/s. Gujarat Green Revolution Co. (GGRC) and along with GGRC registration letter, may file application with the respective Sub division in the format attached herewith."*

**Clarification:**

Any application, registered under Tatkal-2010, they shall have to register application <sup>with GGRC</sup> through sub-division. <sub>our</sub>

- **As per clause No. 9**

*"Those applicants, who had earlier opted for Drip irrigation, but their Drip system is not installed and their application is under*

process at GGRC; and if such applicants, who have not applied under Tatkal Scheme-2010 for switch over, but have applied for registration with GGRC prior to 31st March 11 can also avail this scheme provided connection applied for does not fall in Dark Zone."

**Clarification:**

- Yes, those applicants who have applied in past for MIS-95 and DIS-2007 and their applications are freezed by GGRC due to non-execution of FPA or due to any reason, applications of those applicants can be consider.
- Yes, these applications can be consider<sup>ed</sup>, though they have not executed FPA for any of reasons.
- Yes, applicants who <sup>have applied</sup> are not registered in Tatkal-2010, have to produce the certificate of registration before 31<sup>st</sup> March, 2011 with GGRC to adopt the MIS and applicant have to submit the GGRC registration letter to our sub-division.
