Sub: Fuel Surcharge (FPPPA) for 4th Quarter of 2017-18.

This has reference to our earlier letter MGVCL/FS/2nd Qtr./17-18/3798 dtd. 09.11.2017 intimating to recover FPPPA of Rs. 1.71/ unit for the period Oct- 2017 to December 2017 from all categories of consumers excluding Agriculture consumers.

GUVNL has now worked out FPPPA of Rs.1.63/Unit for 3rd Quarter of FY 2017-18 (base FPPPA of Rs 1.43/Unit plus Rs.0.20/Unit) and submitted the computation of the same to Hon'ble GERC. Thus, there is a decrease of Rs.0.08/Unit in FPPPA from present FPPPA of Rs. 1.71/Unit.

Accordingly, you are requested to kindly charge FPPPA at Rs.1.63/Unit for the period January 2018 To March 2018 and till further communication, from all categories of consumers excluding Agriculture Consumers since Government of Gujarat is giving subsidy to Discoms for Agriculture consumption.

You are requested to circulate this circular immediately to all the concerned field offices under your jurisdiction under intimation to this office and ensure that the Fuel Surcharge as mentioned in this circular is implemented immediately.
