Sub:- Rate of Fuel and Power Purchase Price Adjustment charges (Fuel Surcharge) applicable on the consumption for the month of October- 2018 to December- 2018 and till further instructions.

This has reference to our earlier letter MGVCL/FS/1st Qtr./18-19/1787 dtd. 02.08.2018 intimating to recover FPPPA of Rs. 1.61/ unit on the consumption for the month July-2018 to Sept-2018 from all categories of consumers excluding Agriculture consumers.

GUVNL has now worked out FPPPA of Rs.1.84/Unit (including base FPPPA Rs.1.49/Unit) for 2nd Quarter of FY 2018-19 as against FPPPA of Rs.1.61/Unit for 1st Quarter of FY 2018-19. Thus, there is a increase of Rs.0.23/Unit in FPPPA charges recoverable on consumption from 1st October- 2018.

As per GERC Tariff Order Dtd. 31.03.2018, any levy of fuel surcharge beyond 10 Paise/Unit requires prior approval of Hon'ble GERC.

Since, increase in FPPPA for the 2nd quarter of FY2018-19 Rs.0.23/Unit (increase from Rs.1.61 to Rs.1.84), which is in excess of 10 paise per unit , approval of Hon'ble Commission has been sought for recovery of FPPPA at Rs.1.84/Unit as per Hon'ble Commission order dated 31.03.2018

Meanwhile, you are requested to kindly charge FPPPA at Rs.1.71/Unit (Rs.1.61+0.10) for the period October-2018 To December 2018 and till further communication, from all categories of consumers excluding Agriculture Consumers since Government of Gujarat is giving subsidy to Discoms for Agricultural consumption.

You are requested to circulate this circular immediately to all the concerned field offices under your jurisdiction under intimation to this office and ensure that the Fuel Surcharge as mentioned in the circular is implemented immediately.
