**CIRCULAR**

No.MGVCL/FS/1STQtr/17-18/2911

Sub: Rate of Fuel Price and Power Purchase Adjustment Charges (Fuel Surcharge) applicable on the consumption for the month of April 2017 to June. 2017 till further instructions.

This has reference to our earlier letter No 2345 dated 02.02.2017 intimating to charge Fuel Surcharge @ Rs. 1.76/Unit from all categories of consumers excluding Agriculture consumers .

Hon'ble GERC through Order dated 29.10.2013 has revised formula for computation of Fuel and Power Purchase Price Adjustment (FPPPA-Fuel Surcharge). As per the formula, Hon'ble GERC has allowed to recover FPPPA charges based on incremental average per Unit power purchase cost (including transmission, GUVNL and SLDC cost) over average per Unit cost approved for the base year. Further, Hon'ble GERC has also shifted the base year from FY 2009-10 to 2012-13 for FPPPA calculation. While shifting the base, Hon'ble GERC has considered base FPPPA Rs. 1.20/Unit. Moreover, Hon'ble GERC through Tariff Orders dated 31.03.2016, has considered base Power Purchase Cost Rs. 3.76/Unit.

GUVNL has worked out FPPPA Rs. 2.10 / Unit (including base FPPPA Rs. 1.20/Unit plus 0.86/unit additional expenditure of Q4+UNRECOVERED fpppa OF 4 PAISA PER UNIT OF 2ND Quarter as approved by GERC cide letter dtd.17.3.17)Thus FPPPA OF Rs. 1.76/Unit for 4th Quarter of 2016-17.

Meanwhile, you are requested to kindly **charge FPPPA at Rs. 1.80/Unit (Rs. 1.76 + 0.04) for the period April 2017 to June 2017** and till further communication, from all categories of consumers excluding Agriculture consumers since Government of Gujarat is giving subsidy to Discoms for Agricultural consumption.
