
Sub:- Rate of Fuel and Power Purchase Price Adjustment charges (Fuel Surcharge) applicable on the consumption for the month of January- 2019 to March- 2019 and till further instructions.

This has reference to our earlier letter MGVCL/FS/2nd Qtr./18-19/2629 dtd. 07.02.2019 intimating to recover FPPPA of Rs. 1.99/ Unit (Rs.1.80+0.10+0.09) on the consumption for the period January-19 to March-19 and till further instruction, from all categories of consumers excluding Agriculture consumers.

In this regard, GERC Vide email & letter dated 08.02.2019 has conveyed that GUVNL/DISCOMS shall recover total FPPPA charges of Rs.1.90/Unit for billing quarter of Jan to March-19 instead of Rs. 1.99/Unit and the recovery of the pending amount against Q3 of FY 2018-19 shall be informed in due course.

In view of above directive from GERC, it is requested to charge FPPPA of Rs.1.90/Unit instead of Rs.1.99/Unit conveyed vide earlier letter No. MGVCL/FS/2nd Qtr./18-19/2629 dtd. 07.02.2019, from all Categories of consumers excluding Agriculture consumers for the consumption from 1st January 2019 onwards till further communication from this office.

You are requested to circulate this revised circular immediately to all the concerned field offices under your jurisdiction under intimation to this office and ensure that the Fuel Surcharge as mentioned in the circular is implemented immediately.
