CIRCULAR

Sub: Rate of Fuel Price and Power Purchase Adjustment Charges (Fuel Surcharge) applicable on the consumption for the month of Oct' 2015 to Dec' 2015 till further instructions.

This has reference to our earlier letter dated 03-08.2015 intimating to charge Fuel Surcharge @ Rs. 1.42/Unit from all categories of consumers excluding Agriculture consumers from July 2015 and onward till further communication in this regard.

Hon'ble GERC through Order dated 29.10.2013 has revised formula for computation of Fuel and Power Purchase Price Adjustment (FPPPA-Fuel Surcharge). As per the formula, Hon'ble GERC has allowed to recover FPPPA charges based on incremental average per Unit power purchase cost (including transmission, GUVNL and SLDC cost) over average per Unit cost approved for the base year. Further, Hon'ble GERC has also shifted the base year from FY 2009-10 to 2012-13 for FPPPA calculation. While shifting the base, GERC has considered base FPPPA Rs. 1.20/Unit. Moreover, Hon'ble GERC through Tariff Orders dated 31.03.2015, has considered base Power Purpose Cost Rs. 3.76/ Unit.

GUVNL has worked out FPPPA Rs. 1.42 / Unit (including base FPPPA Rs. 1.20/Unit) for 2nd Quarter of FY 2015-16 as against recovery of FPPPA of Rs. 1.42/Unit for 1st Quarter of FY 2015-16.

You are therefore requested to kindly charge FPPPA Rs. 1.42/Unit for the period October 2015 to December 2015.and till further instructions from all categories of consumers excluding Agriculture consumers since Government of Gujarat is giving subsidy to Discoms for Agricultural consumption.
