1. Qualification:

- 10th Standard passed.
- Should have passed 6 months Fireman Training course from All India Institute of Local Self Government, Nehru Bhavan, Vadodara or equivalent.

2. Experience:

- Five (5) years' service in Army, Navy, Air force, Semi- Government Forces and Police or Home Guards, or Village Protection Forces.

3. A). Physical Standard:

- Height - 165 Cm.
- Weight - 50 Kgs.
- Chest - 81 Cm.
- Chest - 86 Cm. (on expansion)
- Vision - 6/6 without wearing glasses or any other aid. Night or colour blindness shall be disqualification.

B). Endurance Test:

Endurance Test for the selection shall be conducted as per the following criteria:

- Should be able to run a distance of 100 metres (one hundred metres) with 64 Kgs weight in one minute.
- Should be capable of climbing a rope or a vertical pipe to a height of 3 (three) meter from the ground.
- Should be capable of clearing a ditch of 2.7 meters (long jump).
- Should be capable of climbing an extension ladder.
