The complaint dated 18.03.2014 regarding new Agriculture connection in change circumstances.

On 28.03.2014, the case of the Complainant Grievance was heard before Consumer Grievance Redressal Forum wherein Shri Revabhai Parshottambhai Patel, appeared himself whereas Shri R M Patel Deputy Engineer of Kapadwanj REC S/dn appeared as respondent on behalf of MGVCL before the Forum. Both the parties were heard.

The brief details of the case are as under:

1. Shri Revabhai Parshottambhai Patel has applied for new Ag connection in LS No 305 paiki 2 at Kavath Ta: Kapadwanj, Dist: Kheda on dated 12.12.12 at GP No.182.
2. His elder brother Shri Dahyabhai P Patel has also applied for Ag connection in same survey number i.e. LS No.305 & registered application at GP No.2180 dated 17.09.12.

3. The LS 305 P2 is divided among legal heir and as per record now LS No. 305 p2 p1 is own by Shri Revabhai Parsottambhai Patel. It is also reflected in 8-A and 7/12 documents. The applicant requested the Forum to consider the separate survey number and give justice to give Ag connection.

The complainant contended that he and his elder brother had applied for Ag connection for LS 305 P2. He asked the connection in TATKAL scheme on 01-11-2013. MGVCL has cancelled his application as per circular No.15 that only one connection can be given in one survey number. Land was divided before their application and made entry in Hakkpatrak form-6 at entry No. 3198 on 12/01/2009. The Mamlatdar had cancelled this entry saying that there is pending loans on that land. It was informed to Mamlatdar that there was no pending loans on this survey number so the decision taken should be corrected and same is corrected vide entry No. 3750 dated 11-11-2013. There are separate documents of 8-A and 7/12 and his LS is 305/2/1 so requested the Forum to consider his application and give justice.

The respondent contended that the complainant had applied for Ag connection on 12/12/2012 and switch over to TATKAL on 01-11-2013. There were two applications for LS 305/2 so 1st registered application of Shri Dahyabhai Parshottambhai Patel was only considered. As per Hakkpatrak Form-6 entry number 3750 land divided on 11-11-2013 i.e. after application made so application of Shri Revabhai Parsottambhai Patel is cancelled.

The Forum Members present at the hearing considered contention of both the parties and perused the records & observed that the land was divided in 2009 but due to Govt administrative procedures it is corrected in 2013. LS Number 305/2/1 is in the name of Shri Revabhai Parshottambhai Patel

who is sole owner of that land and no other connection exist in that land so new connection can be given.

The forum is of the opinion that after proper verifying the land records proving sole ownership of the land new vij connection should be given to the applicant.

ORDER

The Forum directs the Madhya Gujarat Vij Co Limited to verify the land records proving sole ownership of the land & give new vij connection to the applicant in respect of Shri Revabhai Parshottambhai Patel, At: Fatepura Vanta, Po: Kavath, Ta: Kapadwanj, Di: Kheda

If the complainant is not satisfied with the order of this Forum, the complainant may approach The Staff Officer, Office of the Electricity Ombudsman, Gujarat Electricity Regulatory Commission, Barrack No.3, Polytechnic Compound, Ambawadi, Ahmedabad 380 015 in accordance with Chapter-5, Clause No.13 of GERC Notification No.4 of 2005.

Procedure to make representations before Ombudsman***

1. Representation should be in writing duly signed by the complainant with his name and address.
2. Representation should be supported with affidavit.
3. True copy of order of Forum and original complaint made before Forum should be attached. Enclosed documents should be certified copies of the original documents.
4. The representation before Ombudsman should be submitted within 30 days from the date of order of Forum.
5. Copy of representation should be submitted at the office of Ombudsman. Copy of representation should be submitted to all respondents.
6. If the complainant is required to pay any amount according to the order of Forum, one-third of such amount should be deposited by complainant and proofs should be attached along with the representation.
7. The matter should not be pending before the competent Forum or any other court, tribunal, arbitrator or any other authority.
8. All representations should be with a sufficient cause, reasonable diligence causing the consumer prima facie loss and damages / inconvenience.
9. Representation may be submitted in English or Gujarati language
