STOP DEAL CIRCULAR

MGVCL had placed an order on **M/s Gujarat Safety** for supply of 2500 Pairs Gum boot vide AT at Ref. (2) above.

M/s Gujarat Safety had supplied 2436 Pairs Gum boots against total ordered quantity of 2500 pairs i.e 64 pairs Gum boots were pending for supply .After many times follow up's with M/s Gujarat Safety, vide ref (4) Notice was issued and also vide ref no (6) reminded to supply remaining quantity of Gum boots but M/s Gujarat Safety had neither replied nor offered an inspection call to supply balance quantity of Gum boots.

Final notice was issued vide letter at ref no (8) for the same but M/s Gujarat Safety had neither replied nor supplied balance quantity of Gum boots after passing more then 15 days of final notice.

On non-receipt of reply, MGVCL has issued show-cause notice dated 28.07.2023 vide letter under ref (9) to M/s Gujarat Safety stating:

"why action like Risk and cost purchase of Gum boots, forfeiting the amount against SD, stop dealing with you / your firm, or any other actions as decided by MGVCL competent authority; should not be taken against you / your firm".

By the same notice M/s Gujarat Safety was asked to submit reply within 15 days from the date of receipt of the notice. However, M/s Gujarat Safety didn't submit any reply/representation against the show cause notice issue.

Hence competent authority of MGVCL had decided to call M/s Gujarat Safety for the hearing in the matter and the same was conveyed vide letters under ref.(11) dated.04.09.2023. The hearing was held on 06.09.2023.In hearing M/s Gujarat Safety's representative had committed to reply in E-mail.

On dated 14.09.23,M/s Gujarat Safety had requested to accept remaining (64 Pairs) of Gum boot supply in Black Color instead of Gray Color. Same was put to Competent Authority but Competent Authority had regretted your request which was conveyed to you on Dt-25.09.23.After that till today M/s Gujarat Safety have not supplied 64 Pairs Gum boot as per tender term and conditions

Looking to the all above facts, it is concluded that MGVCL has given enough/sufficient chance/time to M/s Gujarat Safety to supply the material but you have totally failed to supply the materials against Purchase Order placed which result into acute shortage of such item in MGVCL. Thus, failure on your part to execute the Purchase Order is nothing but a breach of Tender terms and conditions

Under this circumstance, Madhya Gujarat Vij Company Limited (MGVCL) has finally decided to take following actions against your firm.

- (1) To stop deal all kinds of business with M/s Gujarat Safety office & Works address at: "Plot no 51,G.I.D.C Phase-1,Avsar Chokdi Nr Water tank, G.I.D.C,Bharuch-392015 ,Gujarat" along with all Directors/Proprietors (1) Suryabanu Asalambhai Junani for the period of One Year from the issue of circular as per tender terms and conditions.
- (2) To forfeit the SD amount of Rs.36,094/- submitted by M/s Gujarat Safety against tender for not supply of pending material (64 Pairs Gum boots) of the Purchase Order, as per tender terms and conditions.
- (3) To recover risk and cost purchase of Rs 8615/-for 64 Pairs Gum boots of pending quantity

This is without prejudice to our other rights in terms of the contract / purchase orders and contentions.
