The ST Category candidates are selected subject to verification of their caste certificate by the Scrutiny Committee formed under the Scheduled Tribe Development of Government of Gujarat. They shall be given appointment only after clearance received from the scrutiny committee regarding validation of their caste certificate.

The candidates at Merit No. (14) and (30) are selected subject to production of latest non-creamy layer certificate.

The candidates at Merit No. (09), (16) and (36) and (130) are selected subject to production of documents for clarification on their name, as it differs from the data filled up by the candidates in online application form.

The candidates at Merit No. (7), (10), (14), (16), (19), (25) and (30) are selected subject to production of Domicile Certificate. In case these candidates do not produce domicile certificate, they shall be considered against 15% quota under the State Government Domicile Policy.

The candidates are selected based on their declaration of scoring 55% in final year of graduation as per result sheet submitted by them and also based on clarification given by concerned Institute/College/University where the candidates have completed their graduation on having secured more than 55% in final year of graduation by the said candidates.

The candidates at Merit No. (2), (8) and (74) have not attended the document verification process. Hence, they shall be again called for document verification process by Corporate office. They shall be given appointment only after satisfactory verification of their testimonials and on clear eligibility for the post of Deputy Superintendent (Accounts).

The above selection is made considering 33% reservation for women. The cut-off marks compared to male candidates is reduced for maintaining 33% reservation for women up to the required women candidates available to maintain 33% reservation, wherever required.

There are many candidates who have scored identical marks. As per the provisions of GSO.156, these candidates have been selected in order of their date of birth i.e. the older candidates have been placed ahead of younger ones and subsequently, on the basis of alphabetical order of their first name.

The roster category candidates who have not been given relaxation in upper age limit are shown as meritorious candidates till the requirement of unreserved category candidates is fulfilled. The roster category candidates who have been given relaxation in age have been appointed against their respective roster category.

The above candidates are selected subject to Final outcome of SCA No. 19129/22 and pursuant to the Order dtd. 27.09.2022 of the H'ble High Court of Gujarat.
