This guarantee shall be valid and binding on Guarantor Bank up to and including \_\_\_\_\_ (insert a validity date being the date falling after 7 months from SCOD) and shall not be terminable by notice or any change in the constitution of the Bank or by any other reasons whatsoever and our liability hereunder shall not be impaired or discharged by any extension of time or variations or alternations made, given, or agreed with or without our Knowledge or consent, by or between concerned parties to the respective agreement.

Our liability under this Guarantee is restricted to **Rs.**\_\_\_\_\_. {in words} only.

Our Guarantee shall remain in force until \_\_\_\_\_ (insert validity date being the date falling after 7 months from SCOD). The **DISCOM** shall be entitled to invoke this guarantee until \_\_\_\_\_ (claim period being a date falling after 8 months from SCOD).

The Guarantor Bank hereby agrees and acknowledges that MGVCCL shall have right to invoke this BANK GUARANTEE in part or in full, as it may deem fit.

The Guarantor Bank hereby expressly agrees it shall not require any proof in addition to the written demand by the **DISCOM** or authorized representative, made in any format, raised at the above mentioned address of the Guarantor Bank or at its branch located in Vadodara in order to make the said payment to the DISCOM or its authorized representative.

The Guarantor Bank shall make payment hereunder on first demand without restriction or conditions and notwithstanding any objection, disputes or disparities by the **Project Developer** or any other person. The Guarantor Bank shall not require the DISCOM or its authorized representative to justify the invocation of this BANK GUARANTEE, nor shall the Guarantor Bank have any recourse against the DISCOM or its authorized representative in respect of any payment made hereunder.

This BANK GUARANTEE shall be interpreted in accordance with the laws of India and the courts at **Gujarat** shall have exclusive jurisdiction.

The Guarantor Bank represents that this BANK GUARANTEE has been established in such form and with such content that it is fully enforceable in accordance with its terms as against the Guarantor Bank in the manner provided herein.

This BANK GUARANTEE shall not be affected in any manner by reason of merger, amalgamation, restructuring or any other change in the constitution of the Guarantor Bank.

This BANK GUARANTEE shall be a primary obligation of the Guarantor Bank and accordingly the DISCOM or its authorized representative shall not be obliged before enforcing this BANK GUARANTEE to take any action in any court or arbitral proceedings against **Project Developer**, to take any claim against or any demand on **Project Developer** or to give any notice to the **Project Developer** to enforce any security held by the **DISCOM** or its authorized representative or to exercise, levy or enforce any distress, diligence or other process against the **Project Developer**.

The Guarantor Bank acknowledges that this BANK GUARANTEE is not personal to the **DISCOM** or its authorized representative and may be assigned, in whole or in part, (whether absolutely or by way of security) by **DISCOM** under intimation to us, to any entity to whom the **DISCOM** is entitled to assign its rights and obligations under the PPA. The Guarantor Bank hereby agrees and acknowledges that the **DISCOM** or its authorized representative shall have a right to invoke this Bank Guarantee either in part or in full, as it may deem fit.

“Notwithstanding anything contained herein above, Our liability under this Bank Guarantee is restricted to Rs. \_\_\_\_\_ (**In words**) and it shall remain in force **until** \_\_\_\_\_ with additional claim period upto \_\_\_\_\_.

We are liable to pay the guaranteed amount or any part thereof under this Bank Guarantee only if the DISCOM or its authorized representative serves upon us a written claim or demand.
