Office Memorandum

Sub: To resume Pre-dispatch inspection of PV Modules within Gujarat State for SURYA Gujarat Scheme

Reference is invited to this Office O.M. dated 23.03.20, 07.04.20 and 21.04.20 vide which deputation of DISCOM's Engineers to carry out the pre-dispatch Inspection of Solar PV modules at OEM was suspended due to COVID-19. Now, some of the module manufacturing factories have resumed functioning.

In view of the above, the deputation of Engineer to carry out PDI of Solar PV modules is now resumed as per following guideline:

1) PDI for Gujarat based PV Module manufacturing Units :

All the PDIs of PV modules is to be carried out by the concerned Engineer of DISCOM in whose jurisdiction is the OEM is situated. (i.e For PDI of Solar PV modules pertain to any DISCOM will be carried out by concerned DISCOM in whose jurisdiction the OEM's factory is situated)

2) PDI for out side Gujarat based PV Module manufacturing Units :

Until the situation is normalized to visit the OEM situated in Maharashtra, West Bengal, Karnataka, Telengana, New Delhi, Hariyana, U.P etc, following time being arrangement is allowed to offer the PDI by Agencies:


- a) Out side Gujarat based OEM of PV modules may tie-up with any Gujarat based OEM of PV Modules manufacturer to carry out PDI.
- b) The lot of supplied modules (pallet) may be kept at nearby Godown and samples of modules for testing to be selected from the pallets by inspector.
- c) All Co-ordination, arrangement and producing all required documents for this way of PDI shall be the responsibility of the concerned Empanelled Agency.
- d) Those Agencies who offer PDI for the outside Gujarat OEMs shall require to inform about Gujarat based OEM address with tie-up letter in Inspection call letter.

3) As per the present practice, Empanelled Agencies shall submit the Inspection calls to concerned DISCOMs and DISCOM shall submit to GUVNL. GUVNL will nominate respective DISCOM to do PDI.

4) PDI shall be carried out in those OEM factories in Gujarat which have obtained necessary approval for running factory from Government under the present lockdown situation.

5) **All Pre dispatch inspections should be done with all the safety protocols of COVID-19 and following the guide lines issued by Government time to time.**

6) This issues with the approval of the Competent Authority.
